- Under section 58 of the Real Estate Agents Act 2008 a licensee (an individual or a company) may request the Registrar to suspend his or her licence for a specified period. This can be done at any time; you do not have to wait until your licence is due to be renewed.
- 2. The licence will be suspended from the date you enter in part 7. The suspension date must be the date you submit the notice, or up to 14 days in the future. You cannot suspend your licence retrospectively or after the expiry date of your licence.
- 3. During the period that your licence is suspended, you cannot carry out real estate agency work.
- 4. It is your legal obligation to advise us of any changes to your contact details within 10 working days of this change.
- 5. You can revive your licence at any time. Please refer to the website for details.
- 6. If you are suspending for longer than a year please note you will have to pay the annual suspension fee. This is due on the anniversary date of the original suspension.
- 7. Levies paid are not refundable. No refunds are paid if a licence is suspended after the licence has been renewed.
